I, wish to reapply/apply to be a member of South Gippsland Animal Aid and to support the purposes of the association as set out in the Association Rules adopted February 2015 as listed below.

Purposes of the Association

1. To rehabilitate and provide short term and long term care to cats and dogs that have been lost, abandoned, mistreated or are without owners and to locate homes for these animals. We are a pro-life organisation committed to caring for every animal we rescue, unless veterinary advice is contradictory.
2. To advocate the desexing of domestic pets, MALE and FEMALE and to assist dog and cat owners with advice and where practical, help with desexing. We are dedicated to reducing the number of unwanted puppies and kittens, many of which have little hope of finding a good home.
3. To act as a charitable institution for the benefit of animal welfare.
4. To maintain a Gift Fund account for the acceptance of donated funds. These funds are to be used only for the principal purposes (i.e. clauses i to ii inclusive) of the Association. The name of the fund is to be SGAA Paws Galore Gift Fund. The withdrawing of funds shall require at least two authorised signatures.
5. That in the event of the dissolution of the Association, any money remaining in the Gift Fund account is to be dispersed to a similar animal welfare association to which tax-deductible gifts can be made.
6. South Gippsland Animal Aid Paws Galore Thrift Shop Inc, is totally run by volunteers in all aspects of its operation, covering management of the Association, Paws Galore Thrift Shop and Foster Carers.

I understand that if my application for membership is approved, I will abide by the Association's rules, as listed in the constitution. If you would like a copy of the constitution, please ask a committee person.
